GENERAL RELEASE

GRIGSBY and USAA, and any agents, servants, successors, administrators and assigns in privity therewith who are or might be liable in any way from any and all claims, actions, causes of action, demands, rights, damages, costs, loss of services, expenses and compensation whatsoever which the undersigned now has or which may hereafter accrue on account of or in any way growing out of any and all known and unknown, foreseen and unforeseen, developed and undeveloped damage and the consequences thereof, resulting or to result from the accident, casualty or event which occurred on or about January 25, 2009, in Brevard County, Florida, and from which accident, casualty or event arose Civil Action No. 2014-CA-66575-XXXX-XX, in the Circuit Court in and for Brevard County, Florida. In further consideration of the above-described payment, LAZARA J. RODRIGUEZ releases and forever discharges STEPHEN W. GRIGSBY, CHRISTINE C. GRIGSBY and USAA against any indemnity or contribution claims of any persons, firms or corporation which occurred or are alleged to have occurred in the accident of January 25, 2009.

The undersigned hereby acknowledges full and final settlement and satisfaction of all claims, demands, actions and causes of action of whatever kind or character which she may have against STEPHEN W. GRIGSBY, CHRISTINE C. GRIGSBY and USAA by reason of the above-mentioned damages or losses, including any claims for bad faith or excess judgment.



GRIGSBY, CHRISTINE C. GRIGSBY and USAA; and it is further understood and agreed that this settlement is in the compromise of a disputed claim, liability being expressly denied.

The undersigned agrees to satisfy any liens or subrogated interest or medical bills arising out of the subject incident prior to disbursement of the settlement proceeds.

THE UNDERSIGNED HAS READ THE FOREGOING RELEASE AND FULLY UNDERSTANDS IT.



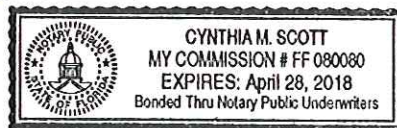
